# Technology Transfer

- Croatian Government has orientation towards building the knowledge-based economy
- Technology transfer from universities and research institutes to business sector is a very important part of this process
- This process has been neglected in Croatia for a long period of time

# University of Zagreb

- The University of Zagreb has strong potential for technology transfer:
  - UZ makes significant part of Croatian academic community
  - UZ has long tradition in science and engineering
- The establishment of the Technology Transfer Office (TTO) may help make this process more efficient

# TTO Working Group

- A working group to establish TTO was established in June 2007 by the Rector of the University of Zagreb
- The main task of the working group was to help establish TTO

## **TTO Goals**

- Promoting the culture of innovativeness and academic entrepreneurship among all components of the University of Zagreb
- Building the system of services for IPR protection and promotion of 'Patenting Culture' among all components of the University of Zagreb

#### TTO Goals cont'd

- Taking proactive steps in helping researchers to shape future applied research projects towards optimal solutions of IP protection and commercialization
- Establishment of the system that will facilitate technology transfer from academic community to business sector and support the academic entrepreneurship

#### TTO Goals cont'd

- Stimulating the commercialization of R&D among all components (Faculties) of the University of Zagreb
- Taking active part in defining consistent and transparent legal and organizational framework for stimulation and smooth conduction of technology transfer at the University of Zagreb

#### TTO Goals cont'd

- Producing all necessary documents (starting from University IPR Policy) in order to achieve the goals mentioned above
- Networking of experts and researchers to facilitate the commercialization of scientific results

## TTO – Basic Activities

- Promotion of 'Patenting Culture' through lectures, seminars, workshops, flyers, electronic advertising and direct contacts with researchers
- Screening for projects with commercialization potential through interviews with principal investigators of research projects
- Creation of necessary documents that will define IP ownership and revenue share scheme at University of Zagreb (IPR Policy)

## TTO – Basic Activities cont'd

- Consulting principal investigators on IPR issues
- Conducting and co-financing of the commercial evaluation procedures for potential inventions
- Decision-making on protection of IP
- Consulting and financing the creation of IP protection documents (patents, copy-rights, contracts etc.)
- Financing of nationalization/regionalization fees for the first year

#### TTO – Basic Activities cont'd

- Consulting and guidance in post-filing period in order to bring the innovation to commercialization through licensing or establishing university spin-off companies
- Establishment of full TTO operation (documents, procedures, contracts, web page, dissemination flyer, list of consultants, networks, databases, etc.)
- Facilitating interdisciplinary research and expertise for complex projects with industry

#### World Bank support

- University of Zagreb to join the "Science and Technology Project" of MSES supported by the World Bank
- Goal: To support activities establishing TTO
- Currently ongoing preparations of business plan required to apply for World Bank financing

## World Bank support

- World Bank would provide financing to support TTO activities:
  - Salary support
  - Consultant services required to establish TTO
  - Equipment
  - Initial funds for IPR protection at University of Zagreb
